## **Membership Classifications and Dues:**

### **Annual Membership**

Unlimited green fees for a single or family. Family includes applicant, spouse, and dependents living inside the household and full-time college students up to age 22. \$150 off pool membership and discounted range balls. Membership year is April 1, 2025 through March 31, 2026.

Annual Dues: \$800

Cart Fees: \$11 for 9 holes, \$20 for 18 holes per person

Range Balls: \$4 for small basket, \$6 for large basket

### **Players Pass**

Single membership for 30 rounds of golf including golf cart. \$150 off pool membership and discounted range balls. Each check in equates to one round of 18 holes. All rounds expire one year from date of purchase.

Annual Dues: \$1,050.

Range Balls: \$4 for small basket, \$6 for large basket

### **Convenience Package**

110 rounds of golf including cart, family pool membership and discounted range balls for single or family. Family includes applicant, spouse, dependents living inside the household and full-time college students up to age 22. After 110 rounds are used, a cart fee will be charged.

Membership year is April 1, 2025 through March 31, 2026.

Annual Dues: \$2,500

Cart Fees: \$11 for 9 holes, \$20 for 18 holes per person

Range Balls: \$4 for small basket, \$6 for large basket

### **Junior Membership**

Same benefits as Annual Membership for high school students only. Membership available until high school graduation. Membership year is April 1, 2025 through March 31, 2026. You may walk anytime Monday – Thursday and after 2pm Friday through Sunday.

Annual dues: \$300

Range Balls: \$4 for small basket, \$6 for large basket

### **Pool Membership**

Membership for family. Family includes applicant, spouse, dependents living inside the household and full-time college students up to age 22.

\$500 for 2025 pool season

\$350 for 2025 pool season with golf membership

## Terms and Conditions of Membership

Most memberships require a 50% deposit at time of purchase and must be paid in full by July 1, 2025 except the convenience membership which can be paid in four, equal, quarterly payments due April 1, July 1, October 1 of 2025 and January 1, 2026. Dues apply to the full fiscal year. **You must have a credit card on file if you choose to have a charge account.** All statements will be emailed on the 1st of the month. The credit card on file will be charged on the 10<sup>th</sup> of the month for any open balances other than member dues. **A member's account is considered past due if payment has not been made by the tenth day of the following month it was due and all privileges and benefits will be suspended until all balances are paid in full. This includes credit cards not processing payment on the 10<sup>th</sup>.** Interest can be charged on past due balances at 1.5% per month. If collection efforts are required, the Member agrees to pay all court costs, attorney's fees and 100% of the amount due. The venue for any action on the collection of any debts arising from this contract will be in the appropriate Commonwealth of Virginia court.

The applicant agrees to be liable for any fees, charges and damages incurred by the Applicant, the Applicant's spouse, their children and their guests including food and beverages, purchases of merchandise and guest fees.

Any membership, other than the Convenience membership, that is not paid in full by July 1 will be terminated. The fiscal year of Auburn Hills Golf Course is determined by the Board of Directors and begins on April 1 and ends on March 31 of the following year (with the exception of Players Pass which is valid from one year of date of purchase). Resignations must be submitted in writing, signed by the member and received by the Advisory Board on or before March 31. Members who are active as of April 1 are bound for the full year's dues of that fiscal year. Members who join after April 1 are obligated for the dues for the remainder of that fiscal year. Any exceptions to this policy shall be at the discretion of the Board of Directors.

All players, members and guests, must check in and register in the Golf Shop before beginning play. Each player's name must appear on the sign in sheet.

Offensive language or actions unbecoming of a golfer will not be tolerated and may result in suspension or termination of members' club use and/or playing privileges at the sole discretion of club management or the board of directors.
